By laws changes recommended by your board of trustees:

Bylaws Amendment on Electronic Meetings

<u>Motion</u>: Propose the members of Unity Truth Center, Inc, DBA Unity Spiritual Center Port Richey in our Annual meeting on February 28, 2021, add these two clauses in the current bylaws.

ARTICLE V - Meetings

Section 1. Annual Meetings.

f. ELECTRONIC MEETINGS. The meetings of the membership, Board of Trustees, Executive Committee as well as Standing and Special committees may be conducted via electronic means, in whole or in part, with the minimum standard being simultaneous aural communication. At such meetings, any member present electronically shall be considered present in person.

(New Addition) g. Suggested Emergency Provisions

In the case of a national emergency declared by the President of the United States, a State Emergency declared by the governor, or a local emergency as determined by a two-thirds (2/3rds) vote of the local ministry trustees present and voting, the Board of Trustees is authorized to meet by electronic means and to have the full power to adjust budgets and cancel/postpone events or reschedule them as electronic meetings. The Board of Trustees may take any other emergency actions deemed helpful and necessary that do not violate other specific provisions of the local ministry bylaws.

<u>**Rationale</u>**: Recommended by UWM. Given todays environment this is sometimes the only safe way, or sometimes affordable way business can be conducted. Face to face meeting are always encouraged when health conditions, time and travel are reasonable. These changes are simply allowing organizations to respond to changing times and technology available when needed.</u>

<u>Motion</u>: Propose the members of Unity Truth Center, Inc, DBA Unity Spiritual Center Port Richey in our Annual meeting on February 28, 2021, amend Article VI in our bylaws regarding the number of board members

ARTICLE VI – Board of Trustees

Section 1. Membership. The Board of Trustees shall be composed of the senior minister or coministers and no fewer than six (6) other trustees and one alternate trustee. The regular and alternate trustees will be elected from among the active membership of UTC at the annual membership meeting. [NOTE: Churches with fifty (50) members or less may choose to have less than six (6) trustees, but no fewer than three (3) trustees.]

<u>To:</u>

ARTICLE VI – Board of Trustees

Section 1. Membership. The Board of Trustees shall be composed of the senior minister or coministers and no fewer than 4 but no more than six (6) other trustees and one alternate trustee. The regular and alternate trustee will be elected from among the active membership of UTC at the annual membership meeting. [NOTE: Churches with fifty (50) members or less may choose to have less than six (6) trustees, but no fewer than three (3) trustees.]

Rationale: It is common as church attendance changes to "right size" the board to reflect the number of congregants that are qualified to serve. Given that no one stepped up to board service for this coming year it seems it is time for us to take this step now. Two board members are retiring; one due to limited term, the other due to personal reasons is not running again. Remaining are four active current members, Ann Boyko, Jeanette Dupee, Karen Noffsinger and Steven Bogard. Reverend Marty remains on the board as minister.
